### Preface

The General Synod is the copyright holder for most liturgical texts authorized for use within the Anglican Church of Canada. The only exceptions are where the General Synod has permission to reprint or to digitally publish liturgical texts whose copyrights are held by other publishers or authors. All General Synod-authorized liturgical texts are published on <https://www.anglican.ca/about/liturgicaltexts/> under two categories:

- *Anglican Liturgy Library (ALL)* - These texts were published by Anglican Book Centre (ABC) Publishing, originally as books, prior to 2004. The License Agreement of the digital resources within the *Anglican Liturgical Library (ALL)* can be found on <https://www.anglican.ca/about/departments/cir/digital-resources/>. These resources are available for non-commercial use by Anglican parishes, dioceses, religious orders and other official entities of The Anglican Church of Canada, with simple acknowledgement of the source and copyright provision.

For example, items sourced from *The Book of Alternative Services* are to be acknowledged:

- Digital Liturgical Library - These liturgical texts were developed after 2004 on <https://www.anglican.ca/about/liturgicaltexts/>. They are digital resources that are only available on this website, and have not been commercially circulated in hard copies. Some of these resources may include material whose primary copyright is held elsewhere. Where that is the case, you will find notice of those permissions in the Introductions and Acknowledgements sections of that resource.

### Copyright Considerations for Liturgical Texts

With churches suspending in-person worship during the COVID-19 pandemic, the General Synod of the Anglican Church of Canada is aware that clergy and lay leaders are connecting with their congregations virtually. As usual, reproduction of texts requires acknowledgement of the original copyright holder and permission granted.

You may reproduce texts (in whole or part) from the *Anglican Liturgical Library (ALL)* and from the Digital Liturgical Library to create digital church bulletins, service booklets or other digital

materials to use in *virtual worship* during this COVID-19 pandemic period; in the same way that you would produce printed service booklets and projected displays.

There shall be no further reproduction of any text from the *ALL* - outside of the terms already stipulated in the License Agreement - without authorization from the General Synod of the Anglican Church of Canada.

Suggested guide list:

- For resources published after 2004, check the copyright notices and terms for reproduction. These include most recently authorized resources such as *Pray Without Ceasing: Morning and Evening Prayer (for all seasons and for Ordinary Time)* and the *Alternative Collects for the Revised Common Lectionary*; each of which includes material whose copyright is held by other sources.
- Obtain permissions for the copyrighted material(s).
- If you alter the text in any way, you must include a notice that indicates that the text has been altered, and by whom.
- Follow all stipulations dictated by external copyright holders for the use of their material(s).
- Document every copyrighted material that you use on any digital platform.
- Do not monetize (allow YouTube to place advertisements) any digital uploads.

### Copyright Considerations for Music

*Common Praise* (1998) is the most widely used hymn book within The Anglican Church of Canada. It includes hymns that are in the common domain (no copyright controls exist) as well as a number of hymns whose copyrights are held by individuals and by publishing companies.

***The General Synod of the Anglican Church of Canada does not hold the copyrights for the hymns contained within Common Praise.***

An index of copyright holders can be found on page 896 of *Common Praise*. You are responsible for obtaining permissions for both reproduction and for performance. These are easier to obtain for non-commercial purposes. Therefore, if you plan to include music in the context of performance or worship in a video upload or livestream, do not monetize any digital uploads by allowing the placement of advertisements.
